The task force discussed the SPD15 action plan deadline in September 2025 and considered creating a standard approach for collecting race and ethnicity data across state agencies. They identified challenges such as resource limitations and the need for dedicated data collection efforts.

IV. Reports from State Agencies

The discussion centered on the development of a statewide guideline, the creation of an implementation strategy, the challenges associated with data collection, and the review of relevant recommendations and values around Social Determinates of Health Data Standard.

Statewide Guideline: The task force emphasized the importance of developing the Social Determinants of Health Data Standard with input from all members. This standard will shape the framework for data collection and reporting across the state.

Implementation Strategy: To ensure the successful adoption of the guideline, the task force discussed creating a playbook for future systems development. This playbook will serve as a practical guide for stakeholders. Efforts will be made to promote the framework and make it actionable, integrating it into data practices.

Data Collection Challenges: The task force acknowledged several challenges in data collection, particularly in race and ethnicity reporting. To avoid double-counting, it is crucial to recognize multiple categories for individuals. Training on data collection standards will be provided to ensure accurate and consistent reporting.

Recommendations and Values: A review of the Office of Management and Budget (OMB) recommendations for equal tabulation was suggested. The task force highlighted the value of recognizing multiethnic and multigenerational households in data reporting. Additionally, it was noted that the term "part Hawaiian" should be avoided to ensure respectful and accurate representation.

Collaboration and Communication	Schedule Inter-Agency Meetings: Hold regular meetings to discuss progress, share best practices, and coordinate efforts.
Engage Stakeholders	Ensure transparency and gather feedback from stakeholders.
Reporting and Documentation	Provide regular updates to 21st CDG and relevant stakeholders
Prepare Final Report	Compile a comprehensive report detailing compliance efforts and outcomes from each agency.
